In 1986, my mother and father, John Earl and Alice Mae Houchins Norfolk, took me to visit the site of some of our ancestor's graves at Fairview Cemetery I n Pike County, Missouri. I had just become interested in "who are my ancestors and where did they come from". It began an incredible journey that I have not once looked back from and my life has become enriched beyond my wildest dream.

Now, not only do I now have a sense of "who are my ancestors were and where did they come from" but along the journey I have meet many cousins, family members and friends. I also was able to spend quality time with my parents as they traveled the back roads of Pike C County, Missouri helping me answer my yearning to know our family history.

Sadly my parents have passed away (Mom in 2002 and Dad in 2007) but they are with me every time I go searching for the "golden nugget". My research work is dedicated to them and all of my ancestors that have helped pave the way.

This is one of a series documents that are the results of research done over a course of time from 1986-2010. Each year when I return to the Missouri area to do family research I found myself returning Pike County cemeteries to take "a few more pictures" of family members that I had discovered through new research.

In September 2009, I decided that the best approach was to "get them all" and began a project to take pictures and index the burials in as many Pike County cemeteries as possible. While I had some pictures on some of the cemeteries, some of the pictures were available on line. For the rest it is "get out there and take pictures". Since I live in Texas that limits the mount of time I am able to do the ground work but the Pike County Genealogy Society and some of the members have been able to provide me with some of the pictures.

As a result, my daughter, Shelli Hill, sister Pat Thomas and her son Troy Moore, and I have adopted Pike County cemeteries and the people buried there. We will continue to further refine these documents. hoping to provide a research tool for others pursuing their dreams of finding their family's history. A large number of my ancestors are located at these cemeteries. They are the easy ones to identify. The rest requires as much, or more research effort but I find it is my passion to identify as many of them as possible. Once you have been bitten by the ancestral research bug it never stops.

My Pike County Missouri ancestors were from the Houchins, Ince, Silvey, Walkley, Givens, Mobley, Irwin and Norfolk lines. As I began the research for the project I began researching people who are not in my family tree but the fact that they are buried near my ancestors tells me that in many cases they knew my ancestors so their stories also became of interest to me.

Once the pictures have been taken it takes 6 month to a year to complete the research and put together the document if there are 1000-1500 people.






LOUISIANA RESIDENT DIES WEDNESDAY
