Making arrangements for yourself and your loved ones is never easy, but we are here for you to help you through the process. Bethany Cemetery plots, lots and sections offer many options to meet your needs and desires.

Plot prices will do not include opening and closing of graves as this is not a service we provide. All plots must have a tombstone with foundation in place within 2 years of burial, weather permitting. Vaults are not required unless the individual passed from a communicable disease.

Only one single individual may be laid to rest in each purchased plot. This may be by way of a green burial, burying cremated remains, or placing a memorial stone (cenotaph).

Associated with every plot purchase are recording and sexton's fees. Recording fees are to assist with printing, mailing, postage, and other associated administrative responsibilities which also includes the official documentation being filed with the Pike County Recorder of Deeds. The cemetery Sexton is responsible for marking the gravesites prior to burials, this fee is to assist with the payment necessary for this to be completed.

The Bethany Cemetery Association Board of Directors will review your purchase request and will contact purchaser(s) with any further information needed. Once approved and recorded, owner(s) will receive a copy of deed(s) and any other documentation in regard to the purchase.

Agreement & Regulations

By signing this agreement, the purchaser acknowledges and agrees to pay the full purchase price listed for the cemetery plot(s). No plot will be officially deeded until payment has been received in full. The purchaser further agrees to abide by all current and future rules and regulations set forth by the Bethany Cemetery Association and to communicate these guidelines to their heirs for continued understanding and compliance. It is the owner(s) and heirs responsibility to make any repairs necessary to keep plots and tombstones cared for. The Association will notify owners/heirs if an issue arises and requires additional funds to rectify. In the event that no heirs can be contacted, the purchaser authorizes the Bethany Cemetery Association to make decisions regarding the care of the tombstone, burial site, and any other pertinent care necessary. The Association reserves the right to place liens on plots that require costly maintenance repairs that are not taken care of within reasonable time by the owner/heirs, in which no burials will be permitted until refund payment has been made.

All individuals listed on this form will receive annual donation information. While no specific donation amount is required, ongoing contributions are essential to support the maintenance and preservation of the burial grounds. Recommended annual donations are \$25 per deeded plot. The purchaser agrees to uphold all rules and responsibilities outlined in this agreement from the date of signing forward.
